The Kano State Government has received financing from the Islamic Development Bank (IsDB) toward the cost of the **Kano State Agro-Pastoral Development Project (KSADP)**, and intends to apply part of the proceeds toward payments under the contract for the **Establishment of Commercial Large Scale Fodder Farms across Kano State**, which include: Land Preparation, 20Km Fencing and Paddocking, Construction of 20km Access Earth Roads, Construction of 20 Offices, Construction of 20 Units Hay Storage and Pasture Seed Stores in the following locations; Panyabo - Doguwa LG (50Ha), Gora - Madobi LG (50Ha), Yar'maraya – Tudun Wada LG (50Ha), Gidan Kifi, Tiga – Bebeji LG (100Ha), Buram Binjar Kafin Gora (50Ha), Badume – Bichi LG (50Ha), 'Yankifi – Kunchi LG (50Ha), Katsarduwa – Danbatta LG (50Ha), Kaci Kura – Kabo LG (50Ha), Wuro Bagga – Bagwai LG (40Ha), Zaura – Ungogo LG (50Ha), Dudduru – Ajingi LG (210Ha), Fajewa - - Takai LG (50Ha), Sayasaya – Albasu LG, (50Ha), Zainawa – LG (50Ha), Lajawa – Wudil LG (50Ha).

2. The **Kano State Agricultural and Rural Development Authority (KNARDA)** now invites sealed bids from eligible bidders for the **Establishment of Commercial Large-Scale Fodder Farms** as per the breakdown in 4 Lots below:

Lot 1: KN/KSADP/W/A.1.1.2/ 0011 – Supply of Farm Machineries (Bailers & Slashers)

Lot 2: KN/KSADP/W/A.1.1.2/0012 – Establishment of Fire Breakers and Pasture Development (Land Preparation, Planting & Fertilizer)

Lot 3: KN/KSADP/W/A.1.1.2/0013 – Construction of Warehouse, Office and Store

Lot 4: KN/KSADP/W/A.1.1.2/0014 – Fencing of the 1,000Ha

Bidding will be conducted through the International Competitive Bidding limited to IsDB member countries (ICB/MC) procedures as specified in IsDB's [Guidelines](#): Procurement of Goods, Works and related services under Islamic Development Bank Project Financing (April 2019 version) and is open to all eligible bidders as defined in the Procurement Guidelines. venture” willing to participate in the bid. The document can be collected during working hours, at the Secretariat of the **KSADP**, KNARDA Building, KM 9 Hadejia Road, Kano.

6. Bids must be delivered to the address below on or before **23/10/2023** from the date of this publication. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders’ designated representatives and anyone who choose to attend at the address below.

7. All bids must be accompanied by a Bid Security of:
