- 1- The Government of Cameroon has received financing from the Islamic Development Bank (IsDB) toward the cost of the Chari-Logone Integrated Rural Development Project, and intends to apply part of the proceeds toward payments under the contract for the construction of access roads phase 3.
- 2- The Project Management Unit under the Ministry of Economy, Planning and Regional Development now invites sealed bids from eligible bidders for the construction of roads in some localities in Chari logone's division. The works will be in manual work (Brushing, Felling of trees, Cleaning the nozzles, Cleaning of the works, Rehabilitation of decking, etc.) and in Mechanized Work Using High Equipment Intensity (Embankment; Excavation; Tread layer; Reprofiling simple; Reprofiling compacting; Formatting the platform; Creation of ditches and outlets; Construction of scuppers; Construction of masonry ditches; Masonry rubble; Reinforced concrete; etc.). The works will be realized at these subdivisions: Makary, Goulfey, Logone birni. The execution period is expected to be around 06 (six) months. To be awarded bidder, you should passed preliminary examination, detail evaluation and criterion of post qualification according to section III of BD.
- 3- Bidding will be conducted through the International Competitive Bidding limited to IDB member countries (ICB/MC) procedures as specified in IsDB's Guidelines: Procurement of Goods, Works and related services under Islamic Development Bank Project Financing [current edition] ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines.
