#### **Project 1: Emergency Support to Flood Response Project in Las Anood and Baladwyen Districts in Somalia**

The Objective of the Project is: to support livelihood, response and recovery among flood affected communities in Las Anood and Baladweyn Districts in Somalia.

**Project Location:** The project was implemented in Somalia.

## Las Anood and Baladweyn Districts in Somalia Project Background:

The recent heavy Gu rains adversely affected basic livelihoods options for families and households in parts of Somalia. The recent multi cluster rapid assessment report indicates that at least 9,560 families have been affected by the floods, of which 360 are displaced<sup>1</sup>. The report further adds that the flooding destroyed/damaged water and sanitation infrastructure, crops in farms, canals, culverts, roads and drainage systems in most towns and dwelling places. The situation has compromised water, sanitation, and hygiene access for most households; with 60% of households assessed relying on unprotected water sources while the majority (90%) of households do not treat water before consumption. This poses great risks of contamination and the spread of water related illnesses are rife. An assessment conducted in May 2020 indicated that at least 30% of households reported cases of Acute Watery Diarrhea (AWD) in the last 2 weeks<sup>2</sup>.

Famine Early Warning System Network (FEWSNET) projected that the number of people affected by acute food insecurity will increase from 1.2 million to 1.6 million in 2020 due to agricultural losses associated with flooding during the Gu rains (April – June 2020) and desert locust infestation on crops and pasture. The situation may further be exacerbated by the impact of the COVID-19 pandemic on domestic market supply chains, household food and income sources. Household income from remittances will likely diminish as economic activities in source countries decrease due to COVID-19<sup>3</sup>. The communities and governments lack adequate financial and technical capacities to address the protracted resulting humanitarian priorities.

With food crops and livestock production affected because of damaged farmlands, pastures and even death of livestock, food security and livelihood options for most people in Las Anood and Baladweyn Districts. Many households rely on either their food crop production for subsistence or dietary/nutritional needs. As such the project will provide sustainable livelihood support beyond dependency on

humanitarian aid. The intervention will provide capital for investment in income generating activities to support livelihood options for vulnerable women, equip women with skills and knowledge on entrepreneurship and business skills.

**Background:** Fragility impedes achievement of the Sustainable Development Goals (SDGs). Exposure to conflict has immediate effects on food and water security.<sup>4</sup> Inequality and discrimination exacerbate food and water security, cause, and perpetuating fragility. Women, the elderly, adolescents, youth, and children, persons with disabilities, indigenous populations, refugees, migrants, and minorities experience the highest degree of socio-economic marginalization in the region. Marginalized groups have the lowest access to water and food because of geographical location, political affiliation, or discrimination policies. Women and youth are overall disproportionately affected in emergencies due to the lack of access to effective surveillance and early-warning systems, and health services.<sup>5</sup> The COVID-19 outbreak is predicted to have significant impacts on various sectors. The populations most at risk are those that: depend heavily on the informal economy; occupy areas prone to shocks; have inadequate access to social services or political influence; have limited capacities and opportunities to cope and adapt and limited or no access to technologies. Somalia has made significant progress since the re-establishment of the Federal Government in 2012. However, the country continues to struggle with recurrent food and water crises, widespread insecurity, political instability, drought and floods which multiply the COVID 19 pandemic effects. More than half a million are on the brink of famine.

**Objective:** to improve the employability of the Internally Displaced Youth through skill development trainings to acquire skills needed to access employment opportunity in the labour market

The aim of this project is to empower 250 internally displaced youth (50% male, 50% female) through technical vocational training to get access to employment opportunities. It seeks to establish an environment and effective platform, where youth may exercise authentic participation to their country's progress and pursue their own visions, dreams, hopes, and concerns pertaining to development and overall well-being. The project activities are grounded on the fundamental evidence that if young people have sufficient income and resources to sustain productive lives, they can achieve economic progress and contribute to the wider good and care for their families.

## Project results and KPIs:

It is expected that the project will have the following results:

- **Impact:** the project will overall contribute to increased skilled human capital that have skills relevant to the labor market needs
- **Outcomes:** the project will have the following outcomes: (i) enhanced capacity of 250 internally displaced youth to engage in productive economic activities; (ii) increased access of 250 Youth to skills development and economic opportunities; and (iii) around 80% of the trained youth employed and receive income from small businesses and occupations.
- **Outputs:** By 2021; the project outputs include: (i) 250 youth (50% males and 50% females) received training in tailoring, welding, carpentering, and mobile repairs; (ii) training kits and tools provided for 4 trainings; (iii) 50% of the youth started small business generating activities; and (iv) around 30% of the youth placed in jobs.

## I. Description of the Assignment

## **b. Objectives**

The Fragility and Resilience Division at Resilience and Climate Action Department, IsDB is seeking the Short-Term consultancy service to assist IsDB to conduct 3 PCR of the following Projects:

- Emergency Support to Flood Response Project in Las Anood and Baladwyen Districts in Somalia (SOM 1017)
- Support for the TADAMON CSO Pandemic Response Accelerator Program for Somalia (SOM1020)
- Skills Development for Internally Displaced Youth, Somalia (SOM1015)

15. The service shall be performed within a period of 30 days starting on 28 February 2024, or any other period as may be subsequently agreed by both parties in writing.

16. The Project Completion Report (PCR) serves as a basis of comparison between the expected state of the project at the time of appraisal and its actual state at the time of the completion. It is a vital document that records how the project was implemented to allow the post-evaluation team to draw lessons to be learned by IsDB and its beneficiary(s) to improve the design and performance of future projects. Thus, it constitutes the first step of the post-evaluation exercise, a self-evaluation instrument that provides basic data against which the IsDB may assess its progress over time and benchmark its performance against other financing institutions. The PCR shall capture and analyze information on the various cycles of the project including (i) the quality-at-entry standards applied through the Readiness Review (ii) the results-based logical framework to guide results-based monitoring, (iii) the implementation progress and results report and (iv) the PCR enhancing quality-at-exit through an increased focus on results, risks and lessons learned.

## **c. Expected Outputs of the Consultant**

The Consultant will prepare three Project Completion Report (PCR) for the above stated projects according to IsDB standards, guidelines, and procedures. The Consultant's reports of the assignment should be based on the IsDB standard template of GCR, which is attached in Appendix – C.

## **d. Scope of the assignment**

19. The scope of the assignments is as follows:

1. **Site Visits:** the consultant will visit the project locations and have formal discussion with the local Authorities and the beneficiaries of the Project.
2. **Review of the EA completion Report:** The consultant shall review the report, particularly about the information on implementation issues faced by the EA, methodologies (approach used by the EA), and key conclusions and recommendations. Based on the review and analysis, the consultant may include some of key findings from this study in the PCR.
3. Analyze the performance and achievements of the project in terms of implementation plans and objectives fixed during the initial Implementation Schedule. The analysis should address the following questions:
  - To what extent did the Project achieve its overall objectives?
  - What and how much progress has been made towards achieving the overall outputs and outcomes of the project (including contributing factors and constraints);
  - To what extent were the results (impacts, outcomes, and outputs) achieved?
4. Assess the project in terms of relevance, efficiency, effectiveness, and sustainability.

The assessment shall answer the following questions:

- i). **Relevance** – Assess the relevance of the project to the Government and IsDB
  - Was the project relevant to the identified needs?
  - Was the project relevant to the IsDB strategic priorities?
  - Were the inputs and strategies identified, and were they realistic, appropriate and adequate to achieve results?
- ii). **Effectiveness** - Describe the management processes and their appropriateness in supporting delivery.
  - Was the project effective in delivering expected results (time and budget)?
  - Was the project implemented according to the schedule?
  - How does the actual project implementation schedule compare with the initial schedule?
  - What are the reasons for any deviations from the original schedule?

- Analyze financial results, the total project cost, financing plan, and disbursements against the estimates made during the appraisal.
- How effective were the strategies and tools used in the implementation of the project?
- How effectively did the project respond to the need of the beneficiaries?

**iii). Efficiency – Of Project Implementation**

- Do the deliveries of the project justify the costs incurred?
- Were the available resources efficiently utilized?
- Did project activities overlap and duplicate other similar interventions?
- Are there more efficient ways and means of delivering more and better results (output and outcomes) with the available resources?
- Could a different approach have produced better results?

**iv). Sustainability- assess economic, environmental, and social sustainability.**

- Do the projects cause natural resources depilation in the long run?
- Were the local communities and stakeholders consulted during the project implementation?
- To what extent is the project revenue needed to cover its O&M costs?
- Does the Executing Agency possess the technical capacity for the project's operation?
- Did the projects address the training needs for operation and maintenance?
- What is the likelihood of continuation and sustainability of projects outcomes and benefits after completion of the projects?
- Describe key factors that will require attention to improve prospects of sustainability of Project outcomes and the potential for replication of the approach?

v). **Lessons learned- what are the lessons:** The recommendations should provide comprehensive proposals for future interventions by answering inter alia the following questions:

- What are the main lessons that have emerged?
- What are the recommendations for similar future interventions?
- What are the problems and obstacles encountered during the implementation of the projects?
- How did the project's financial management processes and procedures affect project implementation?
- What are the strengths, weaknesses, opportunities, and threats of the project's implementation process?
- What are the future intervention strategies and issues?

20. Evaluate the performance of the IsDB, consultants, the borrower Go and relevant partners.

- a. Visit the projects sites (Village, discussions with Local Authorities, community leaders, beneficiaries) and witness achievements of the outcomes as well as coordination and communication among the different stakeholders.
- b. Identify issues and lessons learned from the project and provide recommendations.
- c. Complete the PCR as per the standard reporting template of the Bank incorporating visual (i.e. maps, photos, graphs, tables, posters, plans, etc.) on the project.

**e. Detail task of the assignment**

21. The tasks of the Consultant are as follows:

- a. Coordinate the communication to and interface with Executing Agency, the local Authorities, the community leaders and the project direct beneficiaries.
- b. Prepare a questionnaire for the stakeholders' interviews of each project.
- c. Initiate the required meetings, interviews, and visits to the project area for close communication with key stakeholders.

- d. The draft-1 PCRs for 3 projects to be submitted to IsDB for review and clearance before proceeding to the field. It should include, among other things: (i) the key information of the projects; (ii) major changes in the country's economy and events which may have affected the sector and the project; (iii) known changes in the scope of the projects; (iv) project output and outcome indicators to be quantified during the mission; and (v) brief explanation in each section of the key elements/questions to be assessed during the field mission, stakeholders to be met, and challenges that the Consultant may face. This report will be reviewed by the Bank together with the Consultant through conference call Microsoft Team.
- e. Field visit following the clearance of Executing Agency and IsDB, the consultant proceeds with the field visit: (i) visit the site of the project as per the scope of the project and expected outputs; (ii) hold thorough on-the-ground discussions with the stakeholders including the Executing Agency/Project Management Unit, concerned Development Partners, and end-beneficiaries; (iii) collect all necessary information concerning project implementation, output and outcomes; and (iv) collect photographs & videos of the project outputs and beneficiaries upon consent of the concerned parties.
- f. If necessary, the IsDB team will join the field visit and the consultant should provide/contribute all the required support to facilitate the discussions with all the stakeholders.
- g. The draft-2 PCRs for 3 projects is a further elaboration and completion after the field visit of the Consultant and should point out and explain the eventual variations in terms of project cost, implementation schedule, financing plan and stakeholders' performance. On top of updating the information that is in the draft-1 PCR, it should include among other things: (i) evaluation of the performance of the executing agency, the Bank, the contractors, based on available information; and (ii) lessons learnt and the Consultant's recommendation to the Bank and the Country concerning project implementation and sector intervention.
- h. The draft-2 PCRs should draw attention to the variation from the position envisaged at the time of the appraisal. Assess and verify the results delivered by the project against the project outputs and outcomes detailed in the Results-Based Logical Framework of the project (Annex-1);
- i. The draft-2 PCR should be shared with the Executing Agency for review and comments and capture the EA's view of the challenges met during implementation and recommendation for future intervention.
- j. The final draft PCR should be submitted to IsDB revise based on the field visit, feedback from IsDB and Executing Agency;

- k. Prepare a knowledge product of 15 pages on specific lessons learned and relevant annexes, such as graphs, photos, videos and maps (i.e. Consultant could consider using GIS-RS analysis for comparing before and after salinity and land use of the project area).
- l. Prepare a short presentation slide highlighting key issues and lessons learned from the sites' visit (i.e. slide highlighting key issues and lessons learnt from the project summarizing the main findings of the exercise). The Consultant may participate and defend the report in a conference call to the IsDB Committee (Experts Team at Global Practices of the IsDB). Otherwise, IsDB will select a representative to present the report and take all comments to be conveyed to the Consultant.
- m. Finalize the PCRs based on the final feedback of the IsDB and the Executing Agency;

**f. Deliverable:**

22. The Consultant will produce the following major outputs:

- 1) The first draft PCRs as per the attached PCRs standard format (Appendix – C), including,
  - Site visits with high resolution photos and videos
  - Supporting documents
  - Semi-structured interviews questionnaires
  - List of interviewees
  - Brief note summarizes the interviewees.
- 2) The second draft PCR as per the attached PCR standard format (Appendix – C).
- 3) The Final PCR is based on the feedback of the IsDB and the Executing Agency.

**g. Time Frame of the Assignments:**

- a) The assignment shall be 30 working days.
- b) The IsDB Fragility & Resilience Division will supervise the Consultant and will provide overarching supervision to the process and will provide feedback and guidance to achieve the goal and specific objectives of the consultancy.

- c) All deliverables are expected to be finalized through rigorous consultative meetings and in-depth discussions with the Executing Agency.

**h. Qualification and Requirements:**

23. The Consultant must have the following minimum qualification and requirements:

- a. MSc degree in Economy, Humanitarian studies, social development and related fields.
- b. Work experience in handling similar consultancy tasks in preparation of the PCRs, project evaluation and project management of the Multilateral Development Banks' (MDBs') will be a strong asset.
- c. Language skills fluency in written and spoken and English.
- d. Knowledge of the region and the subject is needed.

**i. Evaluation Criteria:**

24. The contract will be awarded to the highest-ranked technical proposal within the available fixed budget. Financial proposals exceeding the budgetary limit shall not be considered. The following criteria will be used for the evaluation of technical proposals:

- General Qualification	20 points
- Adequacy for the Assignment	50 points
- Experience in the Sector and Region	30 points
- Total	100 points

**j. Budget and Payment Schedule**

25. The total estimated overall fixed budget for this assignment is **USD 15,000 (USD)**, and the financial proposal shall not exceed this budget. Payments are linked to deliverables as defined below:

- a. **First payment in the amount of 20%** of the Contract Price upon receipt of the Inception Report to the Bank, the First Draft PCR for 3 projects.

- b. **Second progress payment in the amount of 30%** of the Contract Price upon receipt and written acceptance of the second draft PCR Report by the IsDB; and
- c. **Final payment in the amount of 50%** of the Contract Price upon receipt and written acceptance of the Final Report by the Isdb.

26. The remuneration perceived by the Consultant includes all his/her costs and profits as well as any tax obligations that may be imposed on the Consultants.

**k. Eoi Submission Process:**
