

TERMS OF REFERENCE FOR CONSULTANTS

Small and Medium-sized Enterprises (SME) Development Specialist focusing on women owned/led Enterprises

(International-Remote)¹

BACKGROUND

IsDB is the recipient of 5 funding allocations under the Women's Entrepreneurs Finance Initiative (We-Fi). These programs are being implemented in 8 countries to be completed by 2027. The first allocation for Building the Resilience of Value-Added Enterprises for women (BRAVE Women) aims to support WSMEs in the fragile and conflict states of Yemen, Nigeria, Burkina Faso. The second award for the Empowering West African Women Small and Medium Enterprises (EWASME) aims to support WSMEs in post-harvest production activities in the rice value chain in Guinea, Niger, Senegal, Sierra Leone. The third and fourth awards were provided at the same time. BRAVE Women Yemen 2.0 Blended Finance is a second phase of the BRAVE Women program building on the success of the first phase of the project and expanding the financial products offered to support SME development through a credit guarantee scheme. The Women in Sanitation Enterprises (WISE) project aims to support women engaging in sanitation related entrepreneurship opportunities in Bangladesh. The fifth and most recent award is for the Khadijah WE Code which will pilot the WE Code (a global initiative established by We-Fi to drive systematic change in how women entrepreneurs are financed) is a joint initiative with the Asian Development Bank to establish a national level push to improve WSMEs access to finance combining conventional and sharia financing and banking industry.

The Bank is looking to hire a subject matter expert to offer essential technical guidance and support for the effective management and successful implementation of the We-Fi programs. Additionally, this individual will provide technical as well as extensive project management support to assist the Operations Team Leader for the BRAVE Women 2.0 project.

PURPOSE OF THE ASSIGNMENT

The WSMEs specialist will be a member of the We-Fi Fund management team under the Resilience and Climate Action Department (RCA). Under the general direction of the We-Fi Fund Lead, the WSME Business Development Specialist will work in direct collaboration with We-Fi country project teams to support the implementation of the IsDB We-Fi Programs. In addition, the consultant will be expected to contribute to the overall Bank's efforts and work to bolster women's empowerment by increasing women's access to economic opportunities focusing on the banking and financial sector to help the Bank improve and diversify how it is supporting women entrepreneurs as drivers of change.

MAJOR RESPONSIBILITIES & DUTIES

The consultant will provide forward-leading programmatic support and thought leadership to the Bank in strengthening the operations and governance of the women entrepreneurship programs

of the IsDB. The consultant will guide and facilitate the delivery of the programs intended objectives. She/he will work in close collaboration with the We-Fi Fund Lead and operations team, and stakeholders in country.

Specific Duties include:

- Assisting in the design and coordinate the implementation of We-Fi Projects
- Coordinating capacity building on how to support SME development through business support services, business incubators, and other innovative approaches;
- Providing input on financing, reporting and monitoring procedures related to initiatives implemented by partners and stakeholders;
- Working with partner institutions to facilitate effective implementation of the SME development initiatives;
- Ensuring preparation of consolidated reports on project activities and participate in the review of M&E reporting and evaluations
- Performing other duties as assigned that are consistent with the Bank's engagement in We-Fi implementation.

BRAVE Women 2.0

The consultant will support the Operational Team Leader in implementing the BRAVE Women 2.0 Program in Yemen serving as Subject Matter Expert providing support on the governance and technical assistance and business advisory support as needed for the grant matching and Credit

Guarantee Scheme. The consultant will be responsible for assisting the project in managing and reporting the financial structure of the credit guarantee scheme, in line with international best practices, to better ensure financial sustainability, outreach, and additionality. Efforts will be directed to improve the enabling environment for women owned/led SMEs in Yemen to help them contribute to diversifying the economy and creating employment.

Major Tasks include, but are not limited to, the following activities:

- Ensure the successful implementation of the project and attainment of targets outlined in the We-Fi proposal.
- Coordinating and managing project implementation with the SFD, SMEPS, and YLG, as well as engaging with partner banks and private sector stakeholders to ensure technical alignment and integration of project objectives.
- Providing technical assistance/advisory services to SFD, SMEPS, and YLG, partner banks and private sector stakeholders;
- Providing capacity development for partner banks and implementing institutions SFD, SMEPS, YLG and partner banks. Developing the capacity of partner institutions to better support SME development in the country;
- Guiding initiatives that support financial institutions on effective engagement and enhanced service for (WSMEs)
- Supporting enhancements in operations, risk management, governance, strategy, and product offerings, while coordinating with partner banks to develop products, manage portfolios, and ensure alignment with project objectives.
- Providing analytical support to tailor recommendations and resolve project implementation issues, aligning strategies with local market conditions and the operational frameworks of SFD, SMEPS, and YLG.
- Identify new business services that emphasize gender equality that support and promote WSME growth.
- Prepare and deliver necessary reports and communication updates as required by the donor.
- Supervise the baseline and evaluation processes.

Qualifications and Requirements:

- The specialist will have a master's degree or higher in economics, finance, or a field related to the scope of work
- At least 10 years of relevant experience in advising governments and the private sector on SME business development in advanced and developing countries and working on credit guarantee systems
- Previous experience in application of Islamic financing mechanisms and Sharia-compliant financial products.
- The specialist will have strong analytical and leadership expertise in identifying strategic policy options and recommending reforms.

- Previous work experience in Fragile and Conflict States is required, in country experience working in Yemen highly preferred.
- The specialist must also demonstrate strong writing skills in English, have a strong client focus, and have excellent communication, and team coordination.
- Strong social analysis and research skills including command of quantitative and qualitative methods of research
- Knowledge of women's empowerment issues in transition and/or developing countries;
- Ability to think strategically, and to innovate, results oriented, ability to work under several deadlines simultaneously; and
- Ability to work in a multicultural team
- Project management skills

- Collaboration with the private sector and integration of WSMEs in supply chains;
- Integration of gender within projects in international organizations (World Bank, African Development Bank; UN Agencies etc.) in the financial sector
