MODE OF FINANCING: Shari'ah IDB LOAN AGREEMENT CMR 1001

- 1- The Government of Cameroon has received financing from the Islamic Development Bank (IsDB) toward the cost of the Chari-Logone Integrated Rural Development Project, Phase II, and it intends to apply part of the proceeds of this financing to payments under the contract for the supply of equipment for rural development centers and spare parts.
- 2- The Project Management Unit under the Ministry of Economy, Planning and Regional Development now invites sealed bids from eligible bidders for the supply of those equipment [three (03) market gardeners and rice weeders, three (03) tractors and accessories, three (03) hullers, twenty (20) mills, twenty (20) tillers] and spare parts. The delivery period is expected to be around 90 days. The project is located in Kousseri.
- 3- Bidding will be conducted through the International Competitive Bidding limited amoung Member Countries procedures as specified in the IsDB's Guidelines for Procurement of Goods and Works under Islamic Development Bank Financing (edition of april 2019), and is open to all eligible bidders as defined in the guidelines.
