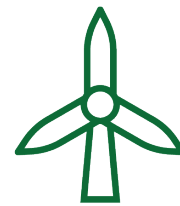

IsDB Group Approvals at a Glance

1975 – 2020 (Q3)

- Total approvals from inception in 1975 to end of third quarter 2020 amounted to US\$ 149.3 billion.
- Net Approvals increased significantly from US\$ 4.4 billion in the first decade (1975-1984) to US\$ 82.0 billion in the last decade (2011-2020).
- A total of 1,086 projects in 78 non-member countries across five continents also benefited from the IsDB Group financing.
- The IsDB Ordinary Capital Resources (IsDB-OCR) accounted for 39.3% of the cumulative group net approvals, followed by ITFC (34.6%) and ICD (3.8%). The remaining 22.3% are coming from ICD managed funds (0.7%), Special Assistance Operations (0.6%), Science, technology and innovation (0.004%) and closed funds (21.0%).
- Approvals for the regions are as follows:
 - Middle East and Europe: US\$ 83.5 billion (55.9%).
 - Asia: US\$ 36.2 billion (24.3%).
 - Africa and Latin America: US\$ 23.6 billion (15.8%).
- The total financing for the top ten countries represent about 62.0 percent of total IsDB Group net approvals as follows:
 - Bangladesh: US\$ 21.8 billion (14.6%).
 - Pakistan: US\$ 13.2 billion (8.9%).
 - Egypt: US\$ 12.7 billion (8.5%).
 - Turkey: US\$ 12.2 billion (8.2%).
 - Morocco: US\$ 6.8 billion (4.6%).
 - Iran: US\$ 6.4 billion (4.3%).
 - Indonesia: US\$ 5.7 billion (3.8%).
 - Saudi Arabia: US\$ 5.4 billion (3.7%).
 - Tunisia: US\$ 4.6 billion (3.1%).
 - Senegal: US\$ 3.6 billion (2.4%).
