- 1- This Specific Procurement Notice follows the general procurement notice sent to the IDB in November 2017 for publication on its website and published in the newspaper "Cameroon Tribune" on 07th December, 2017.
- 2- The Government of Cameroon has received financing from the Islamic Development Bank (IsDB) toward the cost of the Chari-Logone Integrated Rural Development Project, Phase II, and it intends to apply part of the proceeds of this financing to payments under the contract for the development of irrigated land. The Project Management Unit under the Ministry of Economy, Planning and Regional Development now invites sealed bids from eligible bidders for the development of these irrigated lands in some localities in Chari logone's division. The execution period is expected to be around 06 months.
- 3- Bidding will be conducted through the International Competitive Bidding among Member Countries procedures as specified in the IsDB's Guidelines for Procurement of Goods and Works under Islamic Development Bank Financing (current edition), and is open to all eligible bidders as defined in the guidelines.
